

Primary care pharmacy education pathway newsletter

Number 2 – August 2019

This document provides information about the education pathway for pharmacists employed as part of the NHS England primary care Network Contract Directed Enhanced Service (DES) additional roles. At the request of Health Education England, CPPE has reviewed its extended education pathway for pharmacists working in primary care to align with the NHS Long Term Plan and the primary care Network (PCN) Contract DES. The pathway has been renamed the Primary care pharmacy education pathway (PCPEP).

We currently have 220 pharmacists enrolled in the PCPEP training pathway. Applications for cohort 1 will close on 13th September or earlier if we reach maximum numbers. We will open bookings for cohort 2 in the last week of September. As we arrange face to face events around geographical 'hubs', it is important that we know where your pharmacists are.

Some hubs will only run if there is sufficient demand, so please encourage your pharmacists to enrol promptly.

PCPEP handbooks

Your pharmacists will receive a printed copy of the Pathway and role progression and Clinical supervisor and clinical mentor handbooks at the first module 1 induction residential. We will not be printing designed, glossy copies as they need updating too often as the pathway progresses.

Training exemption

As expected, NHSE and HEE require national consistency of competencies for the training of PCN pharmacists and have provided salary support to release pharmacists for training. As an education organisation, CPPE has created a diverse portfolio of learning that ensures plenty of worthwhile learning for all. In some cases pharmacists may be eligible to apply for exemption for all or part of the training pathway.

Examples of exemption of the entire pathway include completion of a previous CPPE pathway with the Statement of Assessment and Progression or completing a recent advanced clinical practitioner qualification in a related role. Partial exemptions may be possible if the pharmacist can prove equivalent learning to different modules on the training pathway

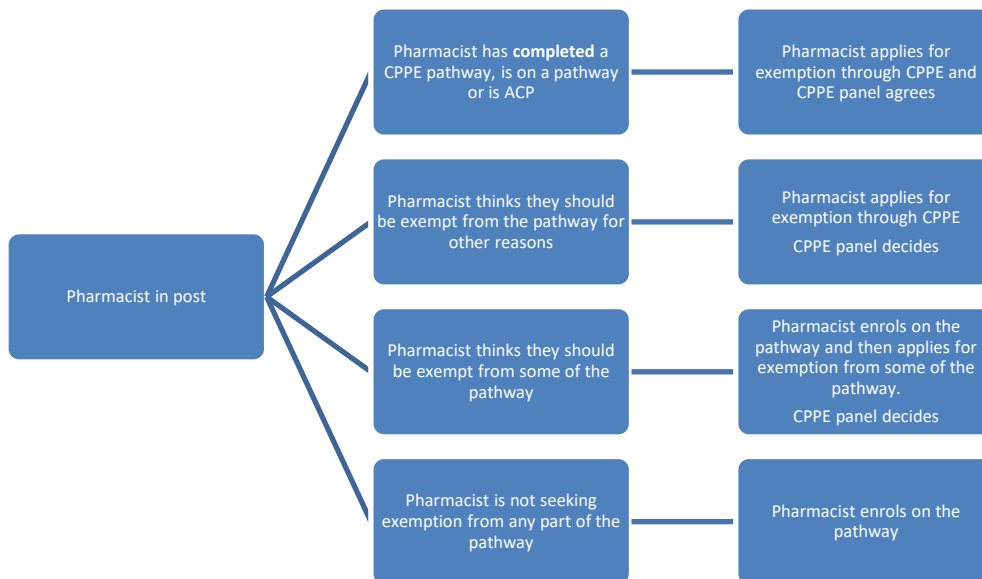


Figure 1 – application for exemption process

Process - all pharmacists funded with NHSE PCN additional funds must either enrol on the pathway or apply for exemption. using the NHSE/HEE agreed process, which is now available on our website <https://www.cppe.ac.uk/career/pcpep/exemptions> . This process creates the necessary audit trail for NHSE/HEE. The application will go to a CPPE panel to decide. An appeals process will be available via a NHSE/HEE panel. Some learning may be available for exempt pharmacists, but will not include 1:1 education supervisor support. The process is outlined in figure 1.

PCPEP Module 1 Residential events

CPPE will be running the seven or eight hubs for Module 1 of PCPEP. **Please note: attendance at the module 1 residentials is compulsory for your pharmacist. If they cannot attend in their region they may book in another region, as long as there is capacity. If they cannot attend any dates they will need to wait until January 2020 and enrol with cohort 2.** Some of these events may be full. The learners will receive information on how to book once they have enrolled on the education pathway.

CPPE education pathways reference group

We have combined the reference groups for CPGP and MOCH with the new primary care pathway reference group to oversee the educational programmes. This will include oversight of the syllabus and assessments; reporting learner, clinical supervisor, clinical mentor and partners experience; and internal quality assurance of educational activities.

The reference group will be an advisory group but does not have formal responsibility as an oversight group, and does not perform a contract assurance function, as this will be carried out separately between HEE and CPPE.

- The Overview and governance of the Primary care pharmacy education pathway, the Clinical pharmacist in general practice pathway and the medicines optimisation in care homes pathway.
- Two-way communication with organisations and their governance groups that members may represent
- Review of delivery and reports relating to quality of provision.
- Review of learners' experience.
- Recommendations and advice to CPPE and partners.
